The Isolating Switching Amplifier type N-132 / \* -\*\*\*, which will be installed outside the hazardous area or in an enclosure which is in accordance with IEC 60079-15 (types N-132/2-E-10 and N-132/1-E-10), is used for converting the intrinsically safe input signals into non-intrinsically safe output signals.

The intrinsically safe circuits are galvanically separated from each other, as from the non-intrinsically safe signal circuits and from the power supply circuit.
